# **TRUSTEE REPORT, JANUARY 2017**

#### **BOARD HIGHLIGHTS**

#### **Enhancing Equity Task Force**

In order to address the challenges and barriers that students living in poverty face in our schools, the TDSB re-established the Inner Cities Task Force last June aiming at auditing and examining the effectiveness of the Model School for Inner Cities program on mitigating the impact of social and economic iniquities.

At the Special Board Meeting on January 12, 2017, the task force was renamed as **Enhancing Equity Task Force** which will put community consultation and participation at the centre of the process and include TDSB Trustees, staff, community advisory committees, parents and students, as well as representatives from many stakeholder groups including community agencies, universities, government and youth.

The final report, which will include concrete recommendations and actions, will be presented at the November 2017 Board. Over the coming months, the task force will assess:

- what the TDSB has done to address the impact of poverty;
- determine what this means for student achievement and well-being; and
- develop recommendations for what must be done now to increase equity.

### **Chair Deputes at Provincial Budget Consultations**

On January 9, 2017, TDSB Chair Robin Pilkey presented the Board's recommendations for the 2017 Ontario Budget. The Chair's deputation focused on:

**Community hubs** - Changes to provincial funding for schools boards and municipal funding must occur to support providing community services and activities in schools. This has become especially evident in recent days with the release of the City of Toronto's recommended 2017 operating budget. Cuts to funding for childcare and community pools will have a direct and negative affect on the lives of thousands of families across the city. In our view, these proposed cuts to the City's budget contradict the provincial vision of community hubs in schools and challenge the TDSB's ability to provide space in our schools. *The cuts clearly demonstrate the need for all levels of government – provincial, municipal and school boards – to work together on a clear community hubs policy that outlines appropriate funding sources to help school boards make these services more accessible for all.* 

**Transportation** - The driver shortage issue experienced in September 2016 continued to plague GTA boards throughout the first quarter of the school year. Parents have high service expectations and the demand for service is outstripping the supply of available drivers. In the absence of provincial funding

benchmarks for transportation, school boards have no guidance to support a change in service expectation and the inequity among coterminous boards is left unaddressed because boards will continue to use transportation as a means to compete for students. *In addition, the TDSB is advocating that transportation for special needs students be identified and funded separately.* 

**Education Development Charges** - It is imperative that the province commit to providing predictable and sustainable funding for school repairs so that the TDSB can continue implementing our long-term plan for renewal, lower our current \$3.4 billion repair backlog and modernize our schools. Toronto City planning figures indicate that 275,000 residential units are in the building process, which could generate EDC revenue of approximately \$300 million in funding for school improvements. Toronto is one of Canada's fastest growing cities. Overlooking the use of EDCs to fund badly needed school repairs is a lost opportunity. As a Board, we will continue to advocate for access to EDCs. *We once again ask the Ontario government to amend the EDC regulations to ensure that the TDSB can capture this revenue and use it to build and repair schools.* 

TDSB has long argued a start to this should be to ensure the provincial benchmark costs which form the basis of funding for education reflect the actual costs in Toronto. For more on funding gaps and TDSB financial facts:

### Speak out against City of Toronto Budget Cuts - Childcare, Student Nutrition, Pools

As part of the City of Toronto Budget 2017, Child Services is recommending phasing out the occupancy grant for childcares located within Toronto schools and freezing subsidized spaces. In addition, the budget is recommending potential cuts to student nutrition programs and operating costs for school pools.

**Budget proposes the elimination of the Childcare Occupancy Grant and cuts to 75 new subsidized childcare spaces.** The elimination of the occupancy grant would mean a fee increase for 60 percent of children who attend childcares in schools alone.

**Budget proposes a \$1.58 million cut to public health spending.** This includes a \$700,000 cut to student nutrition programs. There is a direct relationship between healthy nutrition and academic achievement for students. Nutrition programs are vital to support all children and youth to be ready and able to learn in our classrooms.

**Budget proposes eliminating funding to support three pools located in schools.** This is in addition to last year's city funding reduction for three other pools. Swimming is a key part of physical education and supports students' social, physical, mental, emotional and academic well-being. Cutting funding to more pools will reduce opportunities for more children and families.

What we need – and what children and families need most – is for the city to abandon these harmful budget cuts. If you are concerned, please share this information widely and let your city councillor know that you don't support these cuts.

#### Missing Opportunities: How budget policies continue to leave behind low-income students

Social Planning Toronto released a report on January 12, 2017 about TDSB's use of the Ministry of Education's Learning Opportunities Grant. The purpose of the Learning Opportunities Grant is to provide boards with funding to support the academic achievement of at-risk students. This grant is "unsweatered" which means that boards across the province have considerable discretion and choice in how they use these funds to enhance success for vulnerable students.

LOGs are currently used to support Special Education, Model Schools for Inner Cities, Toronto Foundation for Student Success nutrition programs, classroom teachers supplementing LOI schools and Outdoor Education. However, there are gaps between what we spend in certain areas and the funds we receive from the province in those areas. For example, we exceeded the province's funding for Special Education by more than \$16 million in 2014-15.
