Dear Rexdale Pupil Accommodation Review Committee participants:

We would like to express our deep appreciation for all of the personal time and energy you have invested in making our Rexdale Pupil Accommodation Review Committee (PARC) so successful during the past year.

The following is a brief update as to status of the PARC recommendations:

In the fall of 2012, the Ministry of Education imposed a freeze on all capital projects at Toronto District School Board (TDSB). This means that no new major capital projects involving school renovations, additions or new construction can occur until the Ministry is satisfied with the Board's proposed solution. For our area, this means that no capital projects can be started at any of the schools that were part of the Rexdale PARC. As a result, no changes can occur for September 2013.

TDSB staff will continue to work with the Ministry of Education regarding our capital situation and, in particular, the accommodation plan being proposed for our area. It is our hope that the capital freeze will be lifted soon. We would like to share the staff recommendations with you on April 18<sup>th</sup>, 2013, 6:00 p.m. - 8:00 p.m. at West Humber C.I. (1675 Martingrove Road) before they are presented to the Board of Trustees for approval. Child care and a light supper will be provided. 	Answer: If the Ministry has not replied by November 2013 it will most likely be postponed. Planning explained the process, timelines and capital plans.

	Answer: The process was reviewed. Trustee Hastings will come to SAC's to communicate updates.		
	Comment: Parent information and public open houses /communication and mis-communication was discussed.


