• Tuesday, October 27, 2015 at 7:00 p.m. at Woodbine JHS (2900 Don Mills Rd., North York).

As you may be aware, this area has seen both significant over-enrolment and under-enrolment in several schools. As well, the current program pathways for some students can be challenging and can lead to schools outside our community. A Local Feasibility Team (LFT) consisting of administrators from area schools, our local Trustee, and various central departments such as Planning, French Language, and Special Education has met regularly between January and March 2015 to discuss possible changes to help deal with these issues.

For your information, school closures are <u>not</u> being considered.

A Program Area Review Team (PART) with parent and TDSB representatives has been created to look at proposed solutions. This process is considering possible options and will provide opportunities for parents/guardians and community members to provide feedback and ask questions at the public meeting.
