Dear Parents/Guardians:

This letter is to update you about the Pupil Accommodation Review process involving Gordon A. Brown Middle School, O'Connor Public School, Presteign Heights Elementary School, Selwyn Elementary School, and Victoria Park Elementary School.

On May 24, 2017, the Board of Trustees made the following decisions:

- (a) That the attendance area of Gordon A. Brown Middle School be expanded to include the entirety of the O'Connor Public School junior attendance area, effective 1 September 2018;**
- (b) That O'Connor Public School students previously in-district to Milne Valley Middle School be grandparented conditional upon an older sibling attending Milne Valley Middle School the year the younger sibling enters Grade 6.**

The decisions mean that as of September 1, 2018, the designated middle school for all students living within the O'Connor Public School junior attendance area will be Gordon A. Brown Middle School.

In this context, grandparenting refers to exempting students from the change in attendance area (i.e. the existing area still applies). Students who attend Milne Valley Middle School as of September 1, 2018 may remain at Milne Valley Middle School until they graduate.

I would like to thank all of the parents/guardians and community members who dedicated their valuable time to participate in the consultation process and attend meetings related to the review.
