#### Recommendation

It is recommended that the Charitable Foundation Policy (P043), as presented in this report, be rescinded.

#### Context

The Toronto Foundation for Student Success (TFSS) was founded in 1998 and is an independent registered charity dedicated to support students of the Toronto District School Board (TDSB). On 27 May 1998, the Charitable Foundation Policy (P043) was adopted to affirm TDSB's commitment to support student nutrition programs through its arrangement with TFSS (formerly referred to as the TDSB Charitable Foundation Policy).

TFSS' mission statement, policies and procedures are governed by their Board of Directors. As TFSS operates as an arms-length entity and is not governed by the TDSB, this policy has since become obsolete. A time-limited service contract between the TDSB and TFSS was established on 19 February 2013. The updated contract is currently under review.

It is therefore recommended that the Charitable Foundation Policy (P043) be rescinded.

## **Action Plan and Associated Timeline**

Based on the Governance and Policy Committee's recommendation, this report will be presented to the Board of Trustees for final approval. Subject to the Board's approval, the Policy will be rescinded and removed from the TDSB website and a corresponding communication will be circulated to staff through the System Leader's Bulletin.

#### **Statement**

The Toronto District School Board affirms its commitment to student nutrition programs by establishing the Toronto District School Board Charitable Foundation. This foundation will financially co-ordinate diverse resources to support the Board's Mission Statement: "Our mission is to enable all students to reach high levels of achievement and to acquire the knowledge, skills and values they need to become responsible members of a democratic society." Together with its partners in the community, the Toronto District School Board Charitable Foundation intends to build on existing programs and develop unique new ways to facilitate the academic success of students. Staff will explore ideas for creative, non-traditional projects, outside the regular instructional program, aimed at supporting the desire of students to learn.

The Toronto District School Board Charitable Foundation believes in assisting students to benefit physically, emotionally and intellectually from each school day. Students under stress have difficulty learning--students under extreme stress cannot learn. Some of the Board's students do not have enough to eat, some are living in minimal shelter, some experience violence in their homes. The Board will act as an advocate for these students and will honour them, and build their trust in the Board and pride in themselves. The Board supports the creation of an environment for learning in which students can be successful. The Toronto District School Board Charitable Foundation will support nutrition and other programs in order to address some of these issues.
