1. <u>School-Based Staff Allocation, 2019-20: Non-Classroom and Support Staff</u> [3629]

The Committee considered a report from staff (FBEC:034A, page 1) presenting the second stage of school based staffing allocation for non-classroom teachers and support staff for 2019-20.

On March 20, 2019, the Board approved the first stage of school-based staff allocation, classroom, including 10,363.0 FTE positions of elementary teacher, 4,223.0 FTE positions of secondary teacher and 1,256.0 FTE positions of designated early childhood educator.

(a) Allocate an additional 521.0 FTE positions of *Teacher – Elementary*, as set out in Appendix A;

- (d) Allocate 163 headcount positions (163.0 FTE) of *Vice-Principal Secondary*, as set out in Appendix D;
- (e) Allocate 9.0 FTE positions of *Educational Assistant (Caring and Safe)*, as set out in Appendix E;
- (f) Allocate 2,735.0 FTE positions of *Special Education Support Staff*, as set out in Appendix F;
- (g) Allocate 1,042.0 FTE positions of *School Office Clerical*, as set out in Appendix G;
- (h) Allocate 163.5 FTE positions of *School-Based Safety Monitor*, as set out in Appendix H;
- (i) Allocate 2,828 headcount positions of *Lunchroom Supervisor*, as set out in Appendix I;
- (j) Allocate 93.0 FTE positions of *Aquatics Instructor* in the regular program, as set out in Appendix J;
- (k) Allocate 37.0 FTE positions of *Food Program Assistant*, as set out in Appendix K;
