The Ministry of Education will not be funding CUS Outreach Coordinators and PSI programming for the 2019-2020 school year.

Focus on Youth funding was reinstated for 2018-2019 school year.

In accordance with the TDSB Policies & Procedures, schools will close at 6:00 p.m. during the summer months with the exception of locations with PSI and Parks and Recreation permits. Also as a reminder construction work will typically take place during the summer, March break and Christmas as these are the least disruptive times to school operations.

Field permits will be delayed for approximately 2 weeks due to the very wet weather.

2019-2020 permits will be accepted starting June 1, 2019.
