## Approval of FSLAC Annual Report and Election of 2019-20 Executive:

Parent Co-Chair: Mandy Moore (W7)

Parent Vice-Co-Chairs: Matt Forrest (W9), Charles Zhu (W11), Zeynab Kazi (W22)

FSLAC members and alternates serve 2-year terms, renewable in odd years as per Terms of Refence. As such, FSLAC members re-appointed a non-voting community member from Canadian Parents for French, Mary Cruden for a 2 year term with Rosemary Sutherland and Sharon Beason as alternates.

NB: Trustees who have not already done so, are encouraged to renew and/or fill vacancies for FSLAC members/alternates by the end of 2019.

## 2019-20 Proposed Budget

Members discussed how cuts to transportation will adversely affect families and access to French Immersion/Extended which could reduce enrolment in the programs and FSL revenue.

Concern expressed for families for whom loss of TTC tickets will be an unexpected financial burden and how continued access to tickets for those in need will be communicated. Parent co-chair will raise this with Associate Director Witherow.

## **Update French Review Recommendations**

Members discussed how the 5-day window of publication of recommendations, opportunity to comment and Trustee decision is insufficient for affected parents and communities to fully understand and comment on the staff recommendations:

- 1. Restructure the Board's Intensive FSL Programs leading to a single intensive French Immersion (FI) Program model with two entry points, and elimination of all other entry points and Recommendation
- 2. Establish a minimum intake and a maximum cap at the entry points to ensure program viability and account for attrition rates are not detailed enough to evaluate; not detailed enough information to play out.
- 3. Develop a Core French Action Plan;
- 4. Ensure Inclusive Practices in all FSL Programs;
- 5. Strengthen the current Plan for the Recruitment and Retention of FSL Teachers

Recommendations 1 and 2 are of great concern for equity and inclusion and growth in French programs. Recommendations 3-5 align with FSLAC recommendations to the Board made at the Program and School Services Committee in April 2019. FSLAC questions were submitted to staff prior to the FSLAC meeting. Staff responded that they would present the recommendations and answer

Trustee questions at the Committee of the Whole June 12, 2019 with no opportunity for the FSLAC or

the public to ask questions.

FSLAC members expressed concern about the proposed redistribution plan, transportation plan and rewrite of PR597 for which no details were provided and no consultation was planned. PR597 contains

important commitments by the Board including a spot for every on-time applicant, the

accommodation of siblings and adding new sites.

FSLAC written and oral delegation will share concerns of FSLAC with Trustees at Committee of the
