### **Context**

On November 10, 2021, upon recommendation by the Governance and Policy Committee, the Board of Trustees approved the Policy Review Schedule for the 2021/22 – 2024/25 School Years. The Policy Review Schedule included, among other information, the “GPC target dates”, i.e., preliminary dates for consideration of policy items at the Governance and Policy Committee meetings.

In March 2022, an additional meeting was added to the Governance and Policy Committee calendar for June 16, 2022, in order to accommodate a large volume of upcoming agenda items scheduled for the remainder of the 2021/2022 school year. As a result, certain policy agenda items have been re-allocated by staff between previously scheduled April 27 and June 1 Committee meetings and the newly added June 16 meeting.

The updated GPC target dates were prepared for planning and community awareness purposes and may be further amended as required.
