### SCIG

#### Purpose of the SCG

- Supports innovative and creative projects or activities that engage parents/caregivers and caregivers in school communities.
- Strengthens the capacity/capability, involvement, and effectiveness of School Councils.
- Each School Council may submit one funding request of up to \$1,500 to support eligible initiatives.

SCIG Application Closes	November 28, 2025	
Interim Report Due	February 13, 2026	
Goods Receipt Due	May 15, 2026

# **Food Handling Certificate**

- Q. To what extent is a food handling certificate required? E.g. do volunteers who are supporting schools' pizza day require it?
  - A. Food Handling certification is required for any fun fair or other event where the school is serving food, not packaged items, for example, individually wrapped chocolate bars or chips. For example, if they are selling or giving away hotdogs, food handling certification is required. Alternatively, they could hire an approved vendor who has the certification and public health inspection pass.



#### **Police Reference Check**

Q. Does every parent/caregiver volunteer require a PRC? E.g. supporting pizza day or fun fair?

#### A. PR747-Police Record Check Procedure

- The nature of the activity being volunteered for, as determined by the PRC Office, will dictate the level of PRC required.
- School Council members are not required to submit PRCs. If School Council members volunteer with students in a school
- setting, they will be required to comply with the following subsections.
- All Volunteers who may have direct contact with students must provide the Board with an acceptable PRC.
- At minimum, Volunteers who participate in events or activities at school sites must supply the Board with a CRJMC (Level 2).
- Volunteers who have regular and direct contact with students, as determined by the Principal in consultation with Facilities Services and the PRC Office, will be required to submit a VSC (Level 3) before being permitted to volunteer in that type of setting.
- Any volunteer who accompanies students on an overnight or multi-day excursion to assist with supervision must submit a
- VSC (Level 3).

- The funds are allocated to support an array of activities that support engagement from a district level


