TDSB owns the space within the Google environment and the environment is encrypted. All tools are run through a security assessment.	
		Does Google have a right to access to the data? As a service provider Google has administrative rights to access the system. The TDSB's contract with Google along with Ministry of Education enforces that TDSB owns the space.	
		Can law enforcement request data from google? Google has the ability to provide the data, It is legislated to provide the services; there has been no incident so far to report from TDSB.
