**Mitzie Hunter Named New Minister of Education**

As a result of a cabinet shuffle in Ontario Premier Kathleen Wynne’s government this week, there is a new provincial Minister of Education. Liberal MPP for Scarborough – Guildwood Mitzie Hunter is now Minister of Education. We are looking forward to working with her in support of the success of all our students. She became an MPP in August 2013 and has been a Parliamentary Assistant to the Minister of Community and Social Services and most recently was the Associate Minister of Finance, responsible for the Ontario Retirement Pension Plan. Later that day, other changes to public service executive appointments were announced. George Zegarac becomes the Deputy Minister of Infrastructure and Nancy Matthews has been appointed Deputy Minister of Education on an interim basis. MPPs rose for summer recess after June 9, 2016. They will return to the Legislative Assembly of Ontario on September 12, 2016. There will be one by-election for the vacant seat of Scarborough-Rouge River held by former MPP Bas Balkissoon who resigned on March 22. The government has six months to call this by-election. (Note- Neethan Shan is the NDP Candidate for this by-election).

**Happy National Aboriginal Day – June 21, 2016**

On **June 21** each year, people across Canada mark National Aboriginal Day in recognition of the rights, histories, contributions and achievements of Aboriginal peoples. The unique cultures, languages and spiritual practices of First Nations, Métis and Inuit communities are celebrated nationally and in our city. National Aboriginal Day is held around the time of the summer solstice – the longest day of the year – which has spiritual significance for Indigenous people. In schools across Toronto, we honour this day through cultural activities to build knowledge about the histories and current contexts of Aboriginal peoples in Canada. A growing number of Indigenous students and families are joining us at the TDSB. Through the [Aboriginal Education Centre](#), we are dedicated to developing programs that meet the needs of Indigenous students and families and that enable all students and staff to learn from Indigenous perspectives.

**Media Release – June 8, 2016 – Toronto District School Board Supports Curriculum Recommendations from Truth and Reconciliation Commission of Canada**

Toronto District School Board Trustees and staff are showing their support for the *Truth and Reconciliation Commission of Canada: Calls to Action* with a focus on the recommendations around curriculum. In letters addressed to Education Minister Sandals, Trustees, staff, community members and Elders urge the province to develop and implement a mandatory K-12 curriculum that covers residential schools, treaties and the historical and contemporary experiences of Indigenous peoples in Canada as soon as possible. “In our field of public education, we want to emphasize the importance of honouring these actions for TDSB schools, students and families,” says TDSB Chair Robin Pilkey. Members of the TDSB’s Aboriginal Community Advisory Committee state in their letter, “It goes without saying that, at the TDSB, we believe education is critical in the path towards reconciliation and creating possible places for transformation and justice.” These letters are accompanied by a petition signed unanimously by Trustees in support of implementing the curriculum.

**Quick Facts**

- The TDSB [Aboriginal Education Centre](#) has been developing and implementing Aboriginal programs in TDSB schools since 2006.
- The [Aboriginal Community Advisory Committee](#) is one of the TDSB's community committees. It is comprised of First Nations, Métis and Inuit Elders and community members, as well as non-indigenous allies.
- In June 2015, the Truth and Reconciliation Commission of Canada released its final report and calls to action. This included a recommendation to implement a K-12 curriculum on "residential schools, Treaties, and Aboriginal peoples' historical and contemporary contributions to Canada," (*Truth and Reconciliation Commission of Canada: Calls to Action*, Section 62.i).

**Air Conditioning Concerns**

I thought you might be interested in our communication spokesperson response to media questions regarding air conditioning in schools – we understand how unpleasant it can be for both students and staff – "Many schools were designed and built without the capability for air conditioning and prior to the widespread availability of centralized cooling systems... There are several different types of cooling systems in use, including central chiller plants that service an entire school or sections of a school, localized roof top units that service a specific area, split systems that may service one or two rooms, window units that service individual classrooms and finally, some classrooms instructional spaces have large ceiling fans to provide air movement. The decision as to when the air conditioning is turned on is a local school decision that takes into account the availability of other means of ventilation, operable windows, internal temperatures and external temperatures... The cost to install complete building air conditioning at all schools that don't currently have it would reach into the hundreds of millions of dollars, perhaps even closing in on \$1 Billion depending on a number of factors including type of AC chosen, school wide electrical upgrades, asbestos abatement, etc. – not to mention the added maintenance, replacement and operational costs associated with the installation of AC in all schools. As the TDSB is currently facing a \$3.5 Billion maintenance/renewal backlog, air conditioning of all buildings is not being considered as it is cost prohibitive. Our staff do their very best to make students and staff as comfortable as possible, although we realize it can be unpleasant at times. During warmer days, staff use fans, turn off lights, open windows to create a cross breeze and in some cases, where possible, can move classes to cooler portions of the building such as the library. With regards to students or staff that have a particular susceptibility to heat or have medical concerns, we'd want them to come forward so that we can look to see if an accommodation can be made during warmer days."

**Highlights from the 2016 ParticipACTION Report Card**

"The ParticipACTION Report Card on Physical Activity for Children and Youth is the most comprehensive assessment of child and youth physical activity in Canada. The Report Card synthesizes data from multiple sources, including the best available peer-reviewed research, to assign evidence-informed grades across 12 indicators. Over the years, the Report Card has been replicated in numerous cities, provinces and countries, where it has served as a blueprint for collecting and sharing knowledge about the physical activity of young people around the world. This Report Card includes new Canadian 24-Hour Movement Guidelines for Children and Youth: An Integration of Physical Activity, Sedentary Behaviour, and Sleep – the first of their kind in the world – and, for the first time, assigns a Sleep grade."

**Support for Bill C-241, An Act to Amend the Excise Tax Act (School Authorities)**

On May 11, 2016 the Canadian School Boards Association sent a letter to Prime Minister Trudeau in support of *Bill C-241, An Act to amend the Excise Tax Act (school authorities)*. This is a Private Member's bill introduced by PC Kevin Waugh that seeks to allow school boards to receive the full 100 percent GST rebate. The Ontario Public School Boards' Association joined as a signatory in the Canadian School Boards Association letter. It states: ***The Canadian School Boards Association unanimously supports BILL C-241, An Act to amend the Excise Tax Act (school authorities). This proposed bill would amend the Excise Tax Act so as to increase the goods and services tax rebate rate for school authorities from 68% to 100%.*** The Toronto District School Board voted unanimously to also support the Bill and ask the Chair to write a letter of support.

Whereas:

- School authorities are funded through taxpayer dollars;
- The Government of Canada collects GST on goods and services purchased by school authorities, then refunds 68 percent; and
- The remaining 32 percent is a tax on tax.

We, the undersigned, residents of Canada, call upon the House of Commons to support Bill C-241 which seeks to have the full 100 percent of GST collected by the Canada Revenue Agency refunded to Canadian school authorities.

**Jerry Chadwick, Trustee Ward 22, Scarborough East elected First Vice-President of OPSBA**

At the Annual General Meeting this past weekend in Ottawa, Jerry Chadwick was elected First Vice-President of OPSBA receiving the support of boards across the province. The "*Ontario Public School Boards' Association (OPSBA) represents 31 public district school boards and 10 public school authorities across Ontario, which together serve more than 1.2 million public elementary and secondary students. The Association advocates on behalf of the best interests and needs of the public school system in Ontario.*" Jerry joins the Executive Officers which include President - Laurie French, Limestone DSB ; Past President - Michael Barrett, Durham DSB and Second Vice-President - Cathy Abraham, Kawartha Pine Ridge DSB. I am also honoured to be part of the Executive as Vice-President, Enrolment, representing the TDSB.

**Ontario Public School Boards Association (OPSBA) Priorities for 2016-2017 [www.opsba.org](http://www.opsba.org)**

The OPSBA priorities were reaffirmed through a process which invited input from all trustee members, from boards, from regional councils and from First Nation trustees this past spring. With the addition of a new priority, Advancing Reconciliation: First Nation, Métis and Inuit Education, and new areas of emphasis, these were approved by Board of Directors at their April meeting and forwarded to the AGM for confirmation by OPSBA's membership. The six priority areas are:

- The Whole Child and Student Well-Being
- New Generation Education
- Advocating for the Role of Trustees as Members of the Board and Building Leadership Capacity
- Labour Relations
- Education Funding
- Advancing Reconciliation: First Nation, Métis and Inuit Education

**Changes to Leasing as a Result of Amendments to Regulation 444/98 in May 2016**

School boards that lease to another board cannot charge more than the operating cost of the leased space. In other words, boards cannot make profit on another board. There's a maximum lease rate calculation backed on Ministry benchmarks of school operating costs.

Boards could only lease to commercial operators or private sector after the property has been circulated in accordance with Reg 444/98 and no other public entity with priority ranking expresses interest in the property. We are not required to terminate existing leases with private sector entities, but at the time of lease renewal the board would have to circulate per the regulation.

**Changes to Ontario's Accessible Customer Service Standard**

Changes to the customer service standard under the *Accessibility for Ontarians with Disabilities Act* are coming July 1, 2016.

As a result of these changes:

- Organizations must train all employees on accessible customer service.

- Organizations can only require a support person to accompany someone with a disability for the purposes of health or safety, and in consultation with the person.
- More types of regulated health professionals can certify the need for a service animal.
- The customer service standard is part of the **Integrated Accessibility Standards Regulation**, making it easier for organizations to understand their requirements.

All organizations in Ontario with one or more employees must comply with the changes from July 1, 2016. All public sector organizations, and businesses and non-profits with 20 or more employees must submit their 2017 accessibility compliance report by December 31, 2017.
