Description/Objective	<ul style="list-style-type: none"> <li>• Working group is tasked with gathering ideas for next year’s PRO Grant submission and completing the grant application and report back forms.</li> </ul>
Update	<ul style="list-style-type: none"> <li>• At the May PIAC meeting members voted in support of creating two 2017-2018 PRO Grant proposals:               <ol style="list-style-type: none"> <li>1. Funding for the 2018 Parents as Partners Conference</li> <li>2. Funding for the November 2018 PIAC Conference and targeted PIAC outreach initiatives during the 2017-2018 school year to communities in our board with low parent engagement.</li> </ol> </li> <li>• Co-lead Jennifer Sparks and Co-Chair Trixie Doyle drafted the two proposals and sent them for feedback to the PRO Grant Working Group before submitting them on the <b>due date June 15<sup>th</sup>, 2017</b>.</li> <li>• Not all funds from the 2016-2017 PRO Grant have been used. Funding (\$2500) is still available, but cannot be carried over to next year. PIAC voted to use these funds for the creation of a series of webinars, but this work will not happen within this school year. The Ministry did not specifically allocate these funds to the webinars, so they can be used for the other project (Parents as Partners Conference) included in the grant proposal. Therefore, the working group will make a motion at the June 20<sup>th</sup> PIAC meeting to allocate these funds to the conference.</li> <li>• At the May 15<sup>th</sup> Parents as Partners wrap-up meeting, the advisory committees discussed the report back forms for the 2016-2017 PRO Grants for the Parents as Partners Conference. Each advisory committee will submit their own report back form using the conference budget provided at the meeting, by the <b>final report deadline August 31, 2017</b>.</li> <li>• PCEO provided a letter of support for the PIAC Conference and Outreach proposal.</li> </ul>
