<p>Focus Group and Consultation Session on the Parent and Community Involvement Policy (P023)</p>	<p><u>Guest Speaker:</u> David Cameron, Senior Manager, Research and Development and Amie Presley, Research Coordinator, Research Department</p> <p>The Research and Development department facilitated a focus group and consultation session with EYCAC members regarding the Parent and Community Involvement Policy (P023) review. EYCAC members participated in the Community Advisory Committee review survey.</p> <p>EYCAC members were asked to provide their input and perspective on how to improve community engagement and specifically the work</p>	

of EYCAC and its importance. Members shared their achievements, challenges, experiences and what can be improved as a group.

What is EYCAC role? What is the purpose? What is the perception?

A summary of what EYCAC members discussed:

- At EYCAC meetings TDSB staff feel connected when hearing Child Care Operators discuss their challenges and day to day experiences.
- When representing communities and parents, members are able to be part of the table. Members have a way of bringing stakeholders together. It's important and valuable to bring together schools, staff and community.
- EYCAC bring experiences and works together as a group.
- EYCAC work together with struggles. They learn from each other and listen to one another.
- EYCAC members is a network.
- As a Trustee and a parent to be able to hear from others and understand that there are lots of things that need to be done. We have an incredible Early Years team of staff who interface with our service providers and our parents. There are lots of conversations around this table. As a Trustee, our discussions are engaged and bring value. The many conversations are about issues regarding: safety, security, policy and procedures, EDP, etc. EYCAC members know there are still lots to do (e.g. relationships between our Child Care Operators and Principals).
- EYCAC has brought an impact within community because of the discussions and ideas around the table.
- Conversations taking place outside EYCAC are looked at differently now because of the conversations around this table.
- Being part of this committee gives the opportunity to ask questions and access knowledge.
- As a Trustee, hearing the conversations is beneficial.

<p>TDSB Staff Update</p>	<p>Cynthia Grundmann, Senior Policy Advisor and Manager, Early Years and Child Care Services</p> <ul style="list-style-type: none"> • Staff resignation: Louise Humphreys, EDP Manager. Louise worked and interacted with many EYCAC members and working groups over the year. Child Care Services is currently looking to fill the temporary position as soon as possible to support EDP operations and planning. EYCAC thanks Louise for her service. 	

<p>Other Business</p>	<p>Jacqueline Spence, System Superintendent Equity, Anti-Racism, Anti-Oppression & Early Years provided an overview on the EarlyON Board Report that went to PSSC on January 16, 2020.</p> <ul style="list-style-type: none"> • TDSB is currently having ongoing discussions with the City of Toronto about funding and operational expectations for EarlyON programs operated by TDSB. • At the last Board meeting a brief summary of the current status was presented. TDSB secured an extension until December 2021. • The EarlyON Board Report that was presented was in response to the May 22, 2019 board decision around the Board's financial status. An update was provided to the Board regarding what is currently taking place and to identify possible longer-term solutions. • There is a structural deficit that the Board is facing with EarlyON and staff continue to work closely with the City on how to address and mitigate the deficit moving forward. • Discussion regarding a comparative look between PFLC operations and EarlyONs are being undertaken by TDSB staff. <p>It was shared that communication from Public Health has been sent to parents regarding COVID-19 and the cleaning protocols from the Public Health Agency Canada. It was pointed out that the Provincial Government gave more funding in the past to help support funding additional staffing and supplies to meet the demand. TDSB has not received any information from the Provincial Government regarding additional funding, and schools have fewer custodial staff. The Trustee Co-Chair will be speaking with other members and colleagues regarding protocols, the obligations of the Provincial Government, and the supports needed to be maintained at the</p>

Communication will continue to be forwarded.</p> <p>EYCAC members discussed: A system protocol should be in place regarding sharing information about quarantine.</p>
