Review and Approval of the Notes – November 12, 2020	The notes from January 21, 2021 were approved.	
Election of Co-Chair	Emmy Pantin volunteered to be the Co-Chair; all agreed.	
Co-Chairs' Report	Trustee Aarts informed the Committee that the Annual Human Rights Report was received at the Program and School Services Committee (PSSC) February 17, 2021.  HRAnnualReport.p  df  She also informed the committee that the ICCAC motion regarding early years' staffing supports, also received at PSSC on February 17, 2021, was referred to the Finance, Budget and Enrollment Committee. She indicated that all Trustee Standing Committee meetings are public and the schedule of meetings are available on the TDSB public website:  https://www.tdsb.on.ca/Leadership/Boardroom.  Clarification was provided that these positions are not exclusive to MSIC schools and there was an emphasis made on the importance of these positions and the benefits to MSIC schools. Further clarification was made that these staffing supports are not school based, therefore not driven by enrollment. Presentation: Shameen Sandhu, System Leader, Mental Health and Professional Support Services: Impacts of the Pandemic on Mental Health and Well-Being	Shameen Sandhu, System Leader Mental Health and Professional Support Services provided a presentation to the committee on the Mental Health and Well-Being Supports available to families, students and staff of the TDSB.  Shameen informed the Committee that there are supports such as Social Work available to all Virtual School students. These supports are through the referral process from the student's home school in order to maintain consistency for when the students return to bricks and mortar.  She also informed the Committee that School Mental Health Assist Ontario is looking at mental health and equity and the effect of the pandemic.	
Business Arising from January 21 Meeting Motions/Recommendations	Trustee Aarts updated the Committee that the ICCAC motion regarding early years' staffing supports was referred to the Finance, Budget and Enrollment Committee.	
CSW Update	Steve Salfarlie, CSW LC3 provide an update on the "Community Hub" website. He informed the Committee that the webpage has now been made into a ".com" and ".ca" web platform for wider public access: <a href="www.TDSBhub.com">www.TDSBhub.com</a> and <a href="www.TDSBhub.com">www.TDSBhub.com</a> and <a href="www.TDSBhub.ca">www.TDSBhub.ca</a> .  Colleen Huggins, CSW LC2 provided an update on the Parent Academies that are taking place. She informed the Committee that there a series of Parent Academies anti-Black and anti-Indigenous Racism; there are workshops taking place; and there is digital literacy training taking place. Colleen also informed the Committee that the PRO Grant applications are open and that School Councils can apply to receive up to \$1,500.00 per school.	
	Duane Spencer, CSW LC4 provided an update on the pop-up School Council meetings that are happening. He informed the Committee that these pop-up meetings take place on a bi-weekly basis and provide an opportunity for parents to discuss best practices. Some meetings will have a focus/topic of discussion such as equity. Duane also informed the Committee that he is	

	working with community-based safety networks to address the gun violence that is taking place.  David Forrester, CSW LC1 provided an update on the work being done as a CSW collaboration in LC1. All CSWs in the LC work together to help all the families in the LC to obtain food and other needed resources. So far, 100 families have been supported.  It was indicated that food security for families is an ongoing issue and that Toronto Foundation for Student Success is distributing more food gift cards to families.	
MSIC Update	Stephanie Fearon, MSIC Coordinator provided a link to the Building Critical Consciousness webpage where there is a podcast series called "TDSB Human Library" comprising a collection of audio episodes on topics related to Equity, Anti-Racism, and Anti-Oppression in education. <a href="https://www.tdsb.on.ca/Remote-Learning-Supports-and-Resources-for-Educators/Resources/Building-Critical-Consciousness/Podcast-TDSB-Human-Library">https://www.tdsb.on.ca/Remote-Learning-Supports-and-Resources-for-Educators/Resources/Building-Critical-Consciousness/Podcast-TDSB-Human-Library</a> She indicated that there are currently two podcasts published out of a series of 12.	
Working Group – Updates	Trustee Aarts informed the Committee that the Communications Working Group has been widely distributing the "Community Hub" website.  Trustee Aarts informed the Committee that there are currently two spaces available for Organizational Membership on the Committee. She asked the Committee if there were any suggestions for an organization that should be approached for membership. Suggestions included: Ontario Council of Agencies Serving Immigrants (OCASI)/Settlement Workers in Schools (SWIS); Macaulay Child Development Centre; and Maytree Foundation.
