Update on PIAC School Council Recommendations

The Board approved the following PIAC recommendations:

Recommendation #1 (April 2019)

1. PIAC recommends to the Board that school registration forms include a checkbox to allow parents to consent to the sharing of their email with the school's School Council to facilitate communication and increased engagement by the School Councils with the school community. PIAC requests that this be completed to be included in the 2019 Fall Welcome Packages to parents

Status

The process for creating School council chair accounts in School Messenger is currently being completed. Accounts will be available to school council chairs in January. At the same time a communication that includes the link to school messenger, "how to" support materials and account information and a Messenger Protocol is being developed.

Recommendation #2- Supporting Principals In Strengthening School Council Awareness (May 2019)

- 2.1 The TDSB distributes PIAC's Quick Guide "Fall Tips for Principals" to principals via their Superintendents at the beginning of each school year beginning 2019/2020. This guide is a convenient fact sheet on how principals can support their school council.
- 2.2 That PIAC's School Council Outreach Plan is used in schools identified as having no school councils. Superintendents can assist their principals in building school councils where they do not exist, by sharing and working through PIAC's School Council Building Quick Guides for principals and parents. PIAC suggests principal outreach occurs at year-end (June) to start identifying potential parents for school council for the following school year. We further recommend Superintendents attend a school council meeting in these schools by January of that school year.
- 2.3 The TDSB be held accountable to this process by providing PIAC & the PCEO with annual follow-up including an updated list of schools without school councils each November to allow for timely support of schools struggling with building their school council.

Status:

- PIAC's Quick Guide "Fall Tips for Principals" was shared with Principals and Superintendents in September 2019 as a tool for supporting and building school councils. Superintendents support Principals and school councils in various ways include attending meetings, when and where feasible.
- The school council chair contact distribution has been shared with the PIAC co-chairs for distribution to PIAC members in November. It will be updated and shared again in February 2020. The list includes schools that may not have an active school council will be updated again on February 18, 2020.

PO23 Policy Review Update

- Research team has completed a research scan to support the development of policy provisions/thematic areas for consultation

- Policy provision thematic are being developed using the research scan, existing PO23 main themes and recommendations from the Enhancing Equity Task Force
- Work is being done to develop the on-online engagement forum
- Trustees have expressed interest in joint ward based consultation sessions

- Meeting is to be scheduled with the Consultation Working group to review policy provision/thematic areas and other areas for PIAC participation (e.g. ward representatives co-hosting an online forum with staff)

Parents as Partners (PAP) Conference 2020

- Planning has continues for the conference. The next meeting is scheduled for February 24th 2020.

The TDSB is undertaking a review of secondary schools to ensure all students have equitable access to programs and opportunities. As part of this review, the Board is also reviewing the Optional Attendance Policy (P013), which allows students to apply to schools other than their designated school by home address.
