PIAC BY-LAWS UPDATE

Proposed changes that Operational Effectiveness WG is considering:

- 1) Appointed PIAC Members
 - a) PIAC membership include appointed member with a 1-year term in the following situations:
 - i) Ward Vacancies During a Ward vacancy prior to an election PIAC can appoint a parent/guardian to represent the Ward who is qualified to be a PIAC member
 - ii) At-large Appointments PIAC can appoint up-to 10 members who have submitted application to PIAC (seek to include members from under represented groups)
- 2) Reorganize Governance Working Groups (WG) so there are 3 Governance WGs:
 - a) Coordinating WG (formerly Executive Working Group)
 - b) Governance WG (merging Strategic Planning WG and Operational Effectiveness WG)
 - c) Membership Working Group (no change)

PIAC Website Phase 2

- Building on the success from last summer where PIAC used PIAC funds (\$5,000) that would have been returned to the Ministry of Education to engage a vendor to refresh the PIAC website.
- It appears that there could be up-to \$17,000 that will go unspent this school year.
- There is enormous and continued frustration from PIAC Members and School Council Members with TDSBs current level of IT support to allow parents/caregivers to engage.
- PIAC should engage a vendor to explore additional functionalities to the website to enhance parent/caregiver engagement with their children's education, their school(s), school(s)I community(ies), PIAC, other Advisory Committees and Board.

Motion

I move that PIAC authorize the following budget requests as prioritized until all PIAC funds are depleted for 2022-2023 school year or the total allocation is \$17,000:

- 1) Any budget motion approved at a PIAC Meeting between Sept 2022 and May 2023.
- 2) Up to \$2,000 to Communication WG ongoing expenses (ex. Mailchip, etc.)
- 3) Engage a vendor through RFQ, similar to last year in an amount to deplete remaining PIAC funds.

The RFQ process and approval of vendor will be delegated to the Communications WG similar to last year.
