<b>Date</b>	Nov.17, 2020
<b>Description/Objective</b>	This ad hoc Working Group aims to provide recommendations on Parent/Family Engagement in the Virtual School. Areas of interest are Responsiveness, Communication, Community, Accountability, and relation with Home School Councils.
