# Ward Forum – January 22, 2014 at Davisville Jr Public School from 6:30-8:30 Special Presentation – Balancing the 2015-16 Budget – Carla Kisko, Associate Deputy Director of Finance and Operation @7:30

The budget process for the 2015-16 school year is underway at the TDSB. In past years, this annual process has been extremely difficult because of the many reductions the TDSB has had to make in order to comply with the provincial requirement of balancing the annual budget. Although past years of difficult decisions has made balancing the budget easier in recent years, the Board continues to experience declining enrolment in secondary schools which results in a loss of grants – many of which already do not meet Toronto students' needs. On January 22nd, TDSB staff will share information about the 2015-16 Budget and the expenditure reduction decisions that Trustees will need to make. Please see attached flyer.

- Cold weather: When temperature and/or wind-chill factor indicates -28C or lower children will remain indoors
  due to risk of frost nip and frostbite.
- When temperature and/or wind-chill factor indicates -20 to -28C, recesses may be shortened to 10 minutes and lunch recess may be 20 minutes depending on local conditions. Children should be monitored closely for signs of frost nip, frostbite or difficulty breathing.

## Schools and Engaged Communities Forum (from the TDSB Website)

In addition, the team is also reviewing how the TDSB can be responsive and current to best support safety and care for all students and staff, both before and after critical incidents. #### Mandatory Training - Dealing with Abuse & Neglect of Students Training

As a result of the Inquest into the tragic death of Jeffrey Baldwin, on 14 February 2014, the Coroner's Jury passed 103 recommendations to 13 institutions. Of the 103 recommendations, 12 recommendations (#69 to #80) are specifically directed to the Toronto District School Board. The coordination and facilitation of the work on implementation of the recommendations began in February 2014 with the establishment of the Abuse & Neglect Steering Committee. Of note is recommendation #71 that states: The Toronto District School Board shall, as part of its ongoing and comprehensive review of policies and procedures and prior to the start of the 2014-2015 academic year, implement annual training on the duty to report child abuse and neglect... The training shall be mandatory for all staff, including teachers, early childhood educators, administrators, lunchroom supervisors, trustees, caretakers and office staff, with proof of attendance retained and recorded by Toronto District School Board. I will be participating in training in early February.

- Effects of Residential Schools on Aboriginal Communities
   The Board decided:





Whereas, as an educational institution the Board has an obligation to teach about the failed Canadian vision of education called Residential Schools, as for over 120 years families were separated – parents from children and siblings from each other, as well as the trauma of separation, many residential students suffered abuse; and Whereas, as students graduate and become contributing citizens, they have an obligation as fellow Canadians to work with the First Nations communities to help mitigate the wrongs of the past;

# Therefore, be it resolved:

- (a) That the Director convene a committee of curriculum experts to determine a way for students to graduate with a significant knowledge of the effects of residential schools on Aboriginal communities;
- (b) That the Director present a report on an implementation plan by the end of June 2015.

#### ■ Trustee Retreat

The Board decided:

Whereas, trustees need to set goals for the next four years and guidelines for a healthy working relation-ship among trustees and between trustees and staff;

#### Therefore, be it resolved:

- (a) That a retreat be held for trustees and senior staff, after February 4, 2015 and before the March Break 2015, at a cost-efficient location;
- (b) That a Trustee Retreat Workgroup be established with the following mandate. Mandate
- (i) To establish goals for the Board for the next four years
- (ii) To determine guidelines for a healthy working relationship among trustees
- (iii) To determine guidelines for a healthy working relationship between trustees and staff

# A report on Toronto's school board will explore tensions at the top

Globe & Mail (January 9)

Summary: Margaret Wilson, a consultant appointed by the Ontario government, will weigh in on the toxic relations between Ms. Quan and several trustees in a report set for release this coming week. There is no easy fix. Ms. Wilson's probe caps a string of reports chronicling governance problems at the board. Instead of mutual respect, say education experts and sources close to the board, relations between trustees and senior staff have been characterized by a lack of trust and stonewalling, with both Ms. Quan and Mr. Bolton not sharing information with trustees... Ms. Sandals signalled on Friday that she won't let the latest report into the school board gather dust. "There continue to be ongoing operational and governance issues which demand greater attention," spokeswoman Nilani Logeswaran said in an e-mail. "The Minister intends to work closely with the board to restore public confidence in the TDSB."

# Optional Attendance (from the TDSB Website)

Students who reside within the City of Toronto have the right to attend a school which is designated to serve their residential address. The "Find Your School" section of the website identifies the designated schools for each residential address. Students also have the opportunity to access schools outside of the school that is designated to serve their residential address by applying on optional attendance. Acceptance at these schools is subject to space availability and program suitability. The procedures, conditions and timelines relating to optional attendance are described in the Optional Attendance Policy and the Optional Attendance Operational Procedure.

Each year in January, schools are classified as **limited** or **closed** to optional attendance based on the space they have available for the upcoming school year. A school classified as limited can accept students on optional attendance. A limited school is not obliged to accept all students who apply on optional attendance. Acceptance is conditional upon space being available in the appropriate grade and program. A school classified as **closed** cannot accept any students on optional attendance. Only students residing within the school's attendance area will be accepted. Please note that the optional attendance status is updated every January for admission in September. Please confirm if a limited school has space available by calling the school directly.

- It is the parent/guardian's responsibility to deliver this application to the school or schools of choice.
- Priority of placement in the requested school will be based on a lottery if applications exceed the space available at the requested school.
- If admitted, a student is expected to continue at the requested school until graduation.

#### Grade 4 and Grade 7 Extended French Programs

Applications to the Junior Extended French program are made the year your child is in Grade 3 for entry in September of Grade 4. It is an entirely online process. The extended application process opens – January 5, 2015 and closes – January 29, 2015. Note: Registration is for entry in September 2015. Applications are done on PARS (on-line) – except for Grade 7 Extended which is a paper process as in the past. Information night and information is posted on the TDSB French Programs page.
