Dear Parents/Guardians and Community Members:

I am writing to invite you to two public meetings involving area elementary schools including Davisville JPS/Spectrum Alternative School, Eglinton JPS, Maurice Cody JPS, Oriole Park JPS, Forest Hill Jr & Sr PS, Hodgson Sr PS and Northlea E & MS. The first meeting will occur on **Tuesday, October 20, 2015** at 7:00 p.m. at Hodgson Sr PS (282 Davisville Avenue). To increase opportunities for participation, this meeting will be repeated on **Tuesday, October 27, 2015** at 7:00 p.m. at Forest Hill CI (730 Eglinton Avenue West). The final meeting will be held on **Tuesday, November 17, 2015** at 7:00 p.m. at Hodgson Sr PS.

In May 2015, the Board approved a Long-Term Program and Accommodation Strategy that provides a system-wide approach to program and accommodation planning with a ten-year timeframe. Planning studies for schools in the Yonge and Eglinton area are included in the strategy to deal with the increasing accommodation pressures they face. Some of the aforementioned schools are already over 100% utilization and by 2024, they will all be over-capacity. A number of school sites are also small and/or constrained, thereby limiting the number of portables (if any) that can be placed on site. Potential program and accommodation solutions such as boundary changes and grade changes are being examined to cope with enrolment pressures.

The work to consider options will be done through a review process called a Program Area Review. A Program Area Review Team (PART) with parent and TDSB representatives has been created to look at proposed options. During this process, we are committed to keeping parents/guardians and community members informed and to give you the opportunity to provide feedback and ask questions.

At this time, we are also hoping to realign a number of existing intermediate attendance area boundary anomalies for Forest Hill Jr & Sr PS, Glenview Sr PS and Hodgson Sr PS which would affect some junior schools outside of Ward 11. Please see Appendix 1 on page 2 of this letter for these areas.



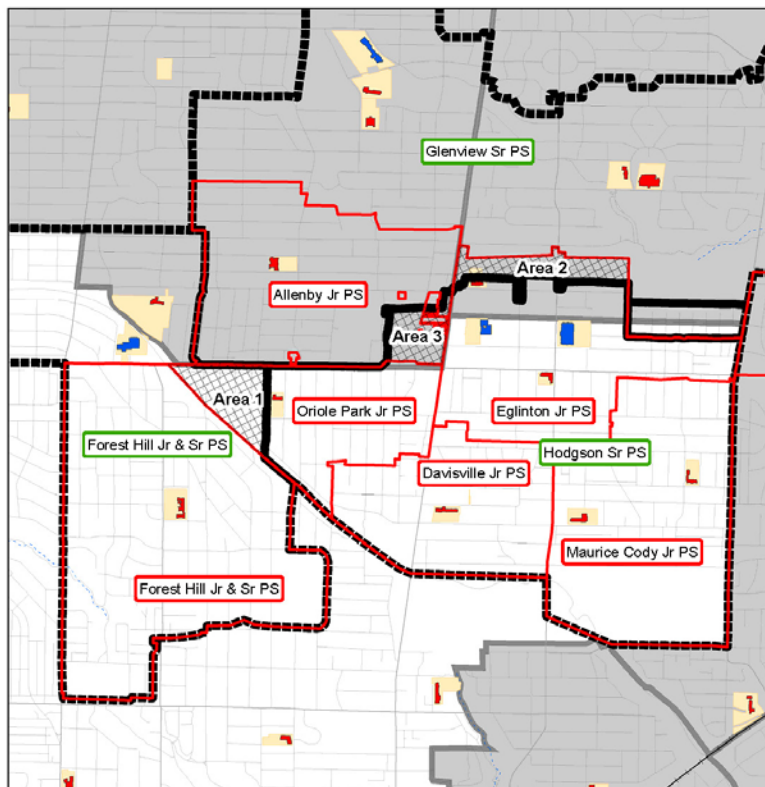
