You are invited to attend a public meeting involving Regal Road Junior Public School, Perth Avenue Junior Public School, Carleton Village Junior and Senior Sports and Wellness Academy, Rawlinson Community School, Brock Public School, and Winona Drive Senior Public School. The meeting will be held on **Monday, April 16, 2018 at 6:00 p.m. at Oakwood Collegiate Institute** (auditorium) located at 991 St. Clair Avenue West.

As part of the 2017-2026 Long-Term Program and Accommodation Strategy (<http://www.tdsb.on.ca/About-Us/Strategy-Planning/Long-Term-Program-and-Accommodation-Strategy>), the Board will be conducting a Program Area Review to study increasing accommodation pressures faced by Regal Road Junior Public School, Perth Avenue Junior Public School and their neighbouring schools.

In order to balance enrolments in this area, the TDSB is assessing potential program and accommodation solutions such as boundary changes and the relocation of programs. A Program Area Review Team (PART) with parent and TDSB representatives has been created to assess options.

I hope you will be able to attend the public meeting on **Monday, April 16, 2018**. There will be an opportunity for parents/guardians and community members to provide feedback and ask questions.


Trustees Marit Stiles and Shelley Laskin have been strong advocates for schools in our communities and will be in attendance to hear your questions and ideas.
