Setting the Context – why are we here?

- TDSB's Long-Term Program and Accommodation Strategy (LTPAS), first approved in 2014 (and updated annually), identifies a number of studies to be undertaken to resolve existing and future accommodation pressures in the City.
- The following study is the focus of this Program Area Review Team (PART) exercise:
 - <u>Boundary Change Study:</u> Explore potential boundary changes involving Carleton Village Jr. & Sr. Sports & Wellness Academy, Regal Road Jr. PS and Perth Avenue Jr. PS to achieve an optimal distribution of students across the three schools while mitigating underutilization at Carleton Village Jr. & Sr. Sports & Wellness Academy.
- The scope of the PART can be expanded if new and/or other issues are identified.

Program Area Review Process

Central Accommodation Team (CAT) Project Launch – September 2017

 Studies in the LTPAS are approved by CAT to commence Local Feasibility Team work

Local Feasibility Team (LFT) - October 2017 to February 2018

- Once approval is received from CAT, an LFT is formed.
- LFT is composed of directly affected superintendents, principals, trustees, and other central staff as required.
- LFT meets to review data and discusses impacts of any proposed changes.
- LFT agrees on recommendation and reports back to CAT.

Program Area Review Team (PART) – March to April 2018

- CAT reviews LFT report and recommends approval to form a PART.
- PART members review data, discuss impacts, and make a recommendation to proceed or not to proceed with any change.
- One of the PART meetings shall be a community meeting to receive broader feedback.
- Once PART has reached decision, superintendent prepares report with recommendations and brings it to CAT for review.

Board of Trustees – June 2018

- After considering the committee's recommendations, central staff shall present its own recommendations to the Board of Trustees for approval.
- Following Board's approval to make change, the affected Superintendents and Principals will notify staff and students and proceed with addressing details related to the transition.





Map of Schools in the Program Area Review Team

Effective <u>September 2019</u>, the LFT recommends the following:

1. Junior Attendance Area Changes


- A boundary change between Regal Road Jr PS and Carleton Village Jr & Sr SWA to direct the portion of Regal Road Jr PS' junior attendance area, west of Lansdowne Avenue and south of Davenport Road, to Carleton Village Jr & Sr SWA;
- A boundary change between Perth Avenue Jr PS and Carleton Village Jr & Sr SWA to direct the portion of Perth Avenue PS' junior attendance area north of the railway tracks to Carleton Village Jr & Sr SWA;
- A boundary change between Regal Road Jr PS and Rawlinson CS to direct the portion of Regal Road Jr PS' junior attendance area, north of St. Clair Avenue West, to Rawlinson CS, and
 - Grandparenting of all students who reside in the current Regal Road Jr PS and Perth Avenue Jr PS attendance areas and attend those schools as of the end of the 2018/19 school year, so that they may be allowed to attend their respective school until they graduate.





2. Intermediate Attendance Area Changes


- A boundary change between Winona Drive Sr PS and Carleton Village Jr & Sr SWA to direct the portion of Winona Drive Sr PS' intermediate attendance area, west of Lansdowne Avenue and south of Davenport Road, to Carleton Village Jr & Sr SWA;
- A boundary change between Brock PS and Carleton Village Jr & Sr SWA to direct the portion of Brock PS' intermediate attendance area north of the railway tracks to Carleton Village Jr & Sr SWA;
- A boundary change between Winona Drive Sr PS and Rawlinson CS to direct the portion of Winona Drive Sr PS' intermediate attendance area, north of St. Clair Avenue West, to Rawlinson CS, and
- A boundary change between Carleton Village Jr & Sr SWA and Rawlinson CS to direct the portion of Carleton Village Jr & Sr SWA's intermediate attendance area, north of St. Clair Avenue West, to Rawlinson CS.
 - Grandparenting of all students who reside in the current Winona Drive Sr PS, Brock PS, and Carleton Village Jr & Sr SWA intermediate attendance areas and attend those schools as of the end of the 2018/19 school year, so that they may be allowed to attend their respective schools until they graduate, and
 - Grandparenting of the following junior to intermediate school pathways up to (and including) the 2026/2027 school year for students who attend the respective junior school as of the end of the 2018/19 school year:
 - Regal Road Jr PS to Winona Drive Sr PS;
 - Regal Road Jr PS to Carleton Village Jr & Sr SWA;
 - Perth Avenue Jr PS to Brock PS.





3. Program Changes

• The future relocation of the Section 23 and Fetal Alcohol Syndrome (FASD) program from Carleton Village Jr & Sr SWA in 2022 (or at a time when enrolment growth requires that additional classroom space be made available at the school). A separate review will be undertaken with Section 23 staff, planning staff, and the local Superintendent to find a suitable site for the Section 23/FASD program.
