Dear Parents/Guardians/Caregivers and Community Members:

You are invited to attend a public meeting to discuss a proposed attendance boundary change involving the following schools: Iroquois Junior Public School, Henry Hudson Senior Public School, Tom Longboat Junior Public School, and Dr. Marion Hilliard Senior Public School.

The meeting will be held at **Tom Longboat Junior Public School** (gymnasium), located at 37 Crow Trail, on **Tuesday, April 23, 2019 from 7:00 p.m. to 8:00 p.m.**

In 2001, the Toronto District School Board (TDSB) approved the redirection of elementary students from the Paradise Homes subdivision located on the southeast corner of Neilson Road and Finch Avenue East. Elementary students are currently assigned to Iroquois Jr PS and Henry Hudson Sr PS (70 students attending Iroquois Jr PS and 12 students attending Henry Hudson Sr PS).

Space in neighbourhood schools has become available; therefore, the TDSB would like to reverse the redirection of students to Iroquois Jr PS and Henry Hudson Sr PS and assign students locally to Tom Longboat Jr PS and Dr. Marion Hilliard Sr PS. This would benefit the community as students would now be able to walk to school.

The proposed change would impact residential addresses on the following streets:

- Blackbird Gate
- Fiddlehead Terrace
- Maidenhair Lane
- Mourning Dove Crescent
- Neilson Park Drive
- Red Hawk Road
- Swallowtail Road

The TDSB has started a Boundary Review to analyze this option. As part of this process, school communities will be consulted before a final decision is made.

The Boundary Review is proposing that any potential change take effect for September 1, 2020 with provisions for some students to remain at their current school. The details of the grandparenting possibility will be explained at the public meeting.
