Must be available for evening and weekend shifts.

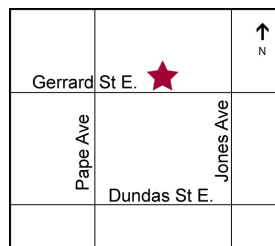
